

RESOLUTION NO. 051115-3

WHEREAS, the Borough Council of the Borough of Gettysburg (the "Borough Council") enacted Ordinance No. 1107-90 (Chapter 15, Part 11), as amended by Ordinance Nos. 1250-01, 1274-03, and 1344-08, regulating the use and operation of the Gettysburg Borough Parking Garage (the "parking garage"); and

WHEREAS, pursuant to Section 15-1103.1. of the aforesaid ordinance, the rates for parking in the parking garage may be revised and changed from time to time by resolution of the Borough Council; and

WHEREAS, the Borough Council desires to adopt a resolution establishing quarterly, bi-annual, annual and guest/visitor parking garage rates and increasing the flat rate for special events parking; and

WHEREAS, the Borough Council also desires by adopting this resolution to confirm the hourly and monthly parking garage rates, as well as a lost ticket fee.

WHEREFORE, BE IT RESOLVED, that the Borough Council of the Borough of Gettysburg does hereby establish, amend, increase or confirm the following rates for the parking garage:

1. Rates:

- a. An hourly rate of seventy-five (\$.75) cents with a maximum rate of ten (\$10.00) dollars per day.
- b. A flat rate (up to 8 hours) of five (\$5.00) dollars during certain designated events.
- c. A lost ticket fee or charge of fifteen (\$15.00) dollars.
- d. A monthly rate of sixty (\$60.00) dollars.
- e. A quarterly (3 months) rate of one hundred seventy (\$170.00) dollars.
- f. A bi-annual (6 months) rate of three hundred thirty-five (\$335.00) dollars.
- g. An annual (12 months) rate of six hundred sixty (\$660.00) dollars.
- h. A one (1) day guest/visitor rate of ten (\$10.00) dollars.

- i. A two (2) day guest/visitor rate of twenty (\$20.00) dollars.
 - j. A three (3) day guest/visitor rate of thirty (\$30.00) dollars.
 - k. A four (4) day guest/visitor rate of forty (\$40.00) dollars.
 - l. A five (5) day guest/visitor rate of forty-five (\$45.00) dollars.
 - m. A six (6) day guest/visitor rate of fifty (\$50.00) dollars.
 - n. A seven (7) day guest/visitor rate of fifty-five (\$55.00) dollars.
2. All other resolutions or parts of resolutions inconsistent herewith are hereby amended and revised accordingly by this resolution.
3. The rates for the parking garage, as established, amended, increased and confirmed by this resolution, are and shall be incorporated accordingly into the comprehensive annual fee resolution (Resolution No. 011215-1) adopted by the Borough Council on January 12, 2015.
4. This resolution shall take effect upon adoption.
