

RESOLUTION NO. 060809-2

WHEREAS, on June 8, 2009, the Borough Council of the Borough of Gettysburg enacted and ordained Ordinance No. 1362-09, its Discharge of Firearms Ordinance; and

WHEREAS, pursuant to Section 6. of the aforesaid Discharge of Firearms Ordinance, the Borough Council of the Borough of Gettysburg shall by resolution establish fees for the issuance of permits for all applications pertaining to its Discharge of Firearms Ordinance; and


WHEREAS, the Borough Council of the Borough of Gettysburg desires to adopt a resolution establishing the fees for the issuance of permits for all applications pertaining to the Discharge of Firearms Ordinance.

WHEREFORE, BE IT RESOLVED, that the Borough Council of the Borough of Gettysburg does hereby adopt the following fees for the issuance of permits for all applications pertaining to its Discharge of Firearms Ordinance:

1. The fee for a single-event permit for an application pertaining to the Discharge of Firearms Ordinance shall be Twenty (\$20.00) Dollars to be paid to the Borough at the time the application is submitted. The single-event permit is valid only for the event described in the permit application. Subsequent events shall require a new permit.
2. The fee for an annual permit (more than one event throughout the calendar year) for an application pertaining to the Discharge of Firearms Ordinance shall be Twenty (\$20.00) Dollars to be paid to the Borough at the time the application is submitted. The annual permit is valid only for the events to be conducted within the calendar year as described in the permit application. Subsequent events shall require a new permit.
3. All other resolutions or parts of resolutions inconsistent herewith are hereby repealed.
4. The provisions of this Resolution may be amended according to law by a resolution duly adopted by the Borough Council of the Borough of Gettysburg and approved by the Mayor of the Borough of Gettysburg.

THIS RESOLUTION DULY ADOPTED according to law on this 8th day of June, 2009 at a regular meeting of the Borough Council of the Borough of Gettysburg.


