

RESOLUTION NO. 060815-2

A RESOLUTION OF THE BOROUGH OF GETTYSBURG, ADAMS COUNTY, PENNSYLVANIA, APPROVING THE INTERMUNICIPAL TRANSFER OF A RESTAURANT LIQUOR LICENSE (LICENSE NO. R-17048) PRESENTLY LOCATED AT 16 EAST HANOVER STREET, BOROUGH OF BONNEAUVILLE, GETTYSBURG, ADAMS COUNTY, PENNSYLVANIA, PURSUANT TO THE REQUEST OF APPALACHIAN BREWING COMPANY OF GETTYSBURG, INC., FOR THE TRANSFER OF THE LICENSE INTO THE BOROUGH OF GETTYSBURG TO PREMISES LOCATED AT 259 STEINWEHR AVENUE, GETTYSBURG, ADAMS COUNTY, PENNSYLVANIA.

WHEREAS, Appalachian Brewing Company of Gettysburg, Inc. (hereinafter "ABC") has made a request of the Borough Council of the Borough of Gettysburg, Adams County, Pennsylvania, for approval of an intermunicipal transfer of Restaurant Liquor License No. R-17048 from premises located within the Borough of Bonneauville at 16 East Hanover Street, Gettysburg, Adams County, Pennsylvania to premises located within the Borough of Gettysburg at 259 Steinwehr Avenue, Gettysburg, Adams County, Pennsylvania; and

WHEREAS, ABC proposes to use said Restaurant Liquor License No. R-17048 in connection with its microbrewery and full-service restaurant to be operated at the premises in the Borough of Gettysburg located at 259 Steinwehr Avenue, Gettysburg, Adams County, Pennsylvania; and

WHEREAS, consistent with the requirements of 40 Pa. Code § 7.61(b)(2), the Borough Council of the Borough of Gettysburg has conducted a duly advertised public hearing on June 8, 2015 for the purpose of receiving comments and recommendations of interested individuals residing within the Borough of Gettysburg concerning the intent of ABC to transfer Restaurant Liquor License No. R-17048 into the Borough of Gettysburg.

WHEREFORE, BE IT RESOLVED, that the Borough Council of the Borough of Gettysburg, Adams County, Pennsylvania, does hereby adopt the following:

1. In consideration of the information provided by ABC and in consideration of the comments and recommendations, if any, from interested individuals residing within the Borough of Gettysburg received at the public hearing held on June 8, 2015, the Borough Council of the Borough of Gettysburg hereby finds that the proposed intermunicipal transfer of Restaurant Liquor License No. R-17048 to premises located within the Borough of Gettysburg at 259 Steinwehr Avenue, Gettysburg, Adams County, Pennsylvania, will not

adversely affect the welfare, health, peace and morals of the Borough of Gettysburg or its residents.

2. Pursuant to 40 Pa. Code § 7.61(b)(4) the Borough Council of the Borough of Gettysburg does hereby approve the request of ABC for the intermunicipal transfer of Restaurant Liquor License No. R-17048 from premises located within the Borough of Bonneauville at 16 East Hanover Street, Gettysburg, Adams County, Pennsylvania to premises located within the Borough of Gettysburg at 259 Steinwehr Avenue, Gettysburg, Adams County, Pennsylvania, in connection with the microbrewery and full-service restaurant use by ABC of the aforesaid premises within the Borough of Gettysburg.

3. A true and correct copy of this resolution, as adopted, shall be submitted to the Pennsylvania Liquor Control Board (hereinafter the "LCB") by ABC along with its application for transfer to the LCB evidencing the approval of the Borough Council of the Borough of Gettysburg, Adams County, Pennsylvania, of the requested intermunicipal transfer of Restaurant Liquor License No. R-17048 from premises located within the Borough of Bonneauville at 16 East Hanover Street, Gettysburg, Adams County, Pennsylvania, to premises located within the Borough of Gettysburg at 259 Steinwehr Avenue, Gettysburg, Adams County, Pennsylvania.

4. This resolution shall take effect upon its adoption by the Borough Council of the Borough of Gettysburg.
