

**RESOLUTION NO. 061316-1**

**WHEREAS**, William E. Troxell was elected as mayor of the Borough of Gettysburg, Adams County, Pennsylvania, in the municipal election held in November 2013; and

**WHEREAS**, William E. Troxell, following his election as mayor of the Borough of Gettysburg in the municipal election held in November 2013 was duly sworn and qualified as mayor of the Borough of Gettysburg for a four (4) year term of office commencing on January 6, 2014 and expiring on the first Monday in January 2018; and

**WHEREAS**, on May 9, 2016, William E. Troxell tendered his resignation from the office of mayor of the Borough of Gettysburg, effective May 31, 2016, which resignation was accepted by a majority vote of a quorum of the Borough Council at a duly advertised general monthly business meeting of the Borough Council which was held on May 9, 2016; and

**WHEREAS**, as a result of the resignation of William E. Troxell from the office of mayor of the Borough of Gettysburg, a vacancy in such office has been created as of June 1, 2016; and

**WHEREAS**, consistent with the provisions of the Borough Code at 8 Pa. C.S.A. §901, the Borough Council of the Borough of Gettysburg shall fill the vacancy in the office of mayor of the Borough of Gettysburg within thirty (30) days of the occurrence of such vacancy by appointing an eligible registered elector of the Borough of Gettysburg to hold such office for the remainder of the term of office which will expire on the first Monday in January of 2018. No person shall be eligible for appointment to fill the vacancy in office of the mayor of the Borough of Gettysburg unless he or she has resided within the Borough of Gettysburg continuously for at least one (1) year immediately prior to his or her appointment; and

**WHEREAS**, the Borough Council of the Borough of Gettysburg desires to appoint an eligible, registered elector of the Borough of Gettysburg to fill the vacancy in the office of mayor due to the resignation from office of William E. Troxell. The person appointed to fill the aforesaid vacancy shall hold such office from the date of this resolution until the first Monday in January 2018, which is the date of the expiration of the term of office of William E. Troxell as mayor of the Borough of Gettysburg, Adams County, Pennsylvania.

**WHEREFORE, BE IT RESOLVED**, that the Borough Council of the Borough of Gettysburg hereby appoints Theodore H. Streeter, as mayor of the Borough of Gettysburg, Adams County, Pennsylvania, in order to fill the vacancy in the office of mayor created by the resignation of William E. Troxell until the first Monday in


January 2018, which is the date of the expiration of the term of office to which William E. Troxell was elected as mayor of the Borough of Gettysburg.

This appointment to the office of mayor of the Borough of Gettysburg is conditioned upon the receipt by the Borough of Gettysburg of a signed affidavit executed and delivered by the aforesaid appointee stating and affirming under oath that: he or she is a registered elector of the Borough of Gettysburg, that he or she currently resides within the Borough of Gettysburg, and that he or she has resided in the Borough of Gettysburg continuously for at least one (1) year prior to his or her appointment.


This action is taken under and pursuant to the power of a borough council to appoint a registered elector of the borough to fill a vacancy in the office of mayor as authorized pursuant to the Borough Code at 8 Pa. C.S.A. §901.
