**A RESOLUTION OF THE BOROUGH OF GETTYSBURG, ADAMS COUNTY, PENNSYLVANIA, AUTHORIZING THE BOROUGH OF GETTYSBURG TO EXECUTE A CERTIFICATE OF INSURANCE IN CONNECTION WITH THE APPLICATION FOR A HIGHWAY OCCUPANCY PERMIT FOR THE MAIN STREET ENHANCEMENT PROJECT.**

**WHEREAS**, as part of the Main Street Enhancement Project, the Borough of Gettysburg, in cooperation with Gettysburg College and its Majestic Theater Renovation Project, desires to make certain improvements to the sidewalk and curbing as set forth in plans for the project as determined by C.S. Davidson, Inc., the Borough engineers; and

**WHEREAS**, in order to facilitate said improvements, the Borough of Gettysburg is required to obtain a Highway Occupancy Permit from PennDot and has applied for the same; and

**WHEREAS**, as a condition of the issuance of the Highway Occupancy Permit, PennDot requires that a Certificate of Insurance be issued by the Borough's insurer and that a Resolution accompany any Certificate that has been countersigned by a designee of a governmental unit; and


**WHEREAS**, the Borough Council of the Borough of Gettysburg desires to authorize Charles W. Sterner, Borough Manager, to countersign said Certificate of Insurance on behalf of the Borough and in support of the application for the Highway Occupancy Permit.

**RESOLVED**, that the Borough Council of the Borough of Gettysburg does hereby authorize the Borough of Gettysburg to execute a Certificate of Insurance in support of its application for a Highway Occupancy Permit as aforesaid.




