

**RESOLUTION NO. 051412 -2**

**WHEREAS**, the Borough Council of the Borough of Gettysburg (the "Borough Council") enacted Ordinance No. 1107-90 (Chapter 15, Part 11), as amended by Ordinance Nos. 1250-01, 1274-03, and 1344-08 regulating the Gettysburg Borough Parking Garage (the "Parking Garage"); and

**WHEREAS**, the Public Safety and Public Works committee of the Borough Council has appointed an ad hoc committee to review issues related to the use and operation of the Parking Garage, the payment of fees for the use of the Parking Garage, and the safe and efficient exit of vehicles from the Parking Garage following events held at either the Majestic Theater or the Gettysburg Hotel and to submit to the Borough Council any recommendations to address the aforesaid issues; and

**WHEREAS**, the ad hoc committee after examining the aforesaid issues has recommended to the Borough Council that a flat rate "chaser" ticket be issued and used on a trial basis for vehicles using the Parking Garage during certain designated events including events held at either the Majestic Theater or the Gettysburg Hotel; and

**WHEREAS**, pursuant to Section 15-1103.1. of the aforesaid ordinance, the rates for parking in the Parking Garage may be revised and changed from time to time by resolution of the Borough Council; and

**WHEREAS**, the Borough Council of the Borough of Gettysburg desires to adopt a resolution establishing on a trial basis a flat rate for parking in the Parking Garage for certain designated events held within the Borough particularly for events held at either the Majestic Theater or the Gettysburg Hotel.

**WHEREFORE, BE IT RESOLVED**, that the Borough Council of the Borough of Gettysburg does hereby adopt the following in connection with the establishment on a trial basis of a flat rate for parking in the Parking Garage for certain designated events held within the Borough:


1. A flat rate of \$4.00 shall be charged for parking in the Parking Garage during certain designated events held within the Borough particularly for events held at either the Majestic Theater or the Gettysburg Hotel. Persons utilizing the Parking Garage during such events shall be issued a "chaser" ticket reflecting the \$4.00 flat rate for parking.
2. The Borough Manager of the Borough of Gettysburg shall be authorized to designate and schedule the dates and times when the aforesaid flat rate shall be in effect and "chaser" tickets shall be issued for parking in the Parking Garage during certain events held within the Borough.

3. The flat rate for designated event parking in the Parking Garage and the issuance of the "chaser" tickets shall take effect and shall be used on a trial basis from May 15, 2012 until October 31, 2012.


4. All remaining provisions of Chapter 15, Part 11, including the parking rates set forth in Section 15-1103, shall remain in full force and effect unless otherwise repealed by any other ordinance or as revised by resolution of the Borough Council. All other resolutions or parts of resolutions inconsistent herewith are hereby repealed.


