**A RESOLUTION OF THE BOROUGH OF GETTYSBURG TO COMMIT TO
PARTICIPATE IN A PEER-TO-PEER TECHNICAL ASSISTANCE PROJECT.**

WHEREAS, representatives from the municipalities within the Gettysburg School District, and the Pennsylvania Department of Conservation and Natural Resources (DCNR) met to discuss the possible creation of a joint regional recreation commission; and

WHEREAS, the proposed recreation commission would provide recreational opportunities for the residents of the Participating Municipalities or parts thereof which make up the Gettysburg School District and other adjacent areas; and

WHEREAS, DCNR has grant funds available requiring a 10% match for the preparation of a Regional Recreation Study to be prepared as a Peer-to-Peer Technical Assistance Project; and

WHEREAS, Cumberland Township has agreed to fund the 10% matching funds; and

WHEREAS, The Borough of Gettysburg, Adams County, Pennsylvania desires to participate in the preparation of the aforementioned Regional Recreation Study; and

NOW THEREFORE, BE AND IT IS RESOLVED by the Borough of Gettysburg, Adams County, Pennsylvania, as follows:

1. The Borough of Gettysburg hereby authorizes and directs Cumberland Township to be the lead applicant for the Regional recreation Study Grant.
2. The Borough of Gettysburg will hereby appoint one elected official and one at-large citizen to the advisory group which will assist DCNR in preparing the study and that in the event there is difficulty in providing this representation; the Borough Secretary/Manager is authorized to attend.

ORDINANCE NO. 1356-08

**AN ORDINANCE OF THE BOROUGH OF GETTYSBURG
REPEALING CHAPTER 6, PART 9 OF THE CODE OF ORDINANCES
OF THE BOROUGH OF GETTYSBURG PROHIBITING LOITERING.**

The Borough Council of the Borough of Gettysburg hereby enacts, adopts, and ordains the following:

SECTION 1: Chapter 6, Part 9 of the Code of Ordinances of the Borough of Gettysburg, entitled "Loitering Prohibited," previously ordained by the Borough Council of the Borough of Gettysburg by Ordinance 1101-90 enacted on June 11, 1990, is hereby repealed in its entirety.

SECTION 2: All remaining provisions of Chapter 6 of the Code of Ordinances of the Borough of Gettysburg shall remain in full force and effect unless otherwise repealed by any other ordinance. All other ordinances and parts of ordinances inconsistent herewith are hereby repealed only to the extent that the same are inconsistent herewith.

SECTION 3: This Ordinance shall become effective upon enactment.




