

RESOLUTION NO. 121117-3

WHEREAS, AmyBeth Hodges was duly elected in the municipal election held in November 2015 and subsequently qualified as a member of the Borough Council of the Borough of Gettysburg in the Third Ward of the Borough of Gettysburg for a four (4) year term of office which term commenced on January 4, 2016 and will expire on the first Monday of January 2020; and

WHEREAS, on November 11, 2017, AmyBeth Hodges tendered her written resignation as a member of the Borough Council of the Borough of Gettysburg, which resignation was accepted by a majority vote of a quorum of the Borough Council at a duly advertised general monthly business meeting of the Borough Council which was held on November 13, 2017; and

WHEREAS, as a result of the resignation of AmyBeth Hodges as a member of the Borough Council of the Borough of Gettysburg in the Third Ward of the Borough of Gettysburg, a vacancy in such elective office has occurred effective on November 13, 2017, the date on which the resignation from office of Ms. Hodges was accepted by a majority vote of a quorum of the Borough Council; and

WHEREAS, consistent with the provisions of the Borough Code at 8 Pa. C.S.A. §901, the Borough Council of the Borough of Gettysburg shall fill the vacancy in the elective office of a member of Borough Council within thirty (30) days of such vacancy by appointing an eligible registered elector of the Third Ward of the Borough of Gettysburg to hold such office for the remainder of the term of office which will expire on the first Monday in January of 2020. No person shall be eligible for appointment to fill this vacancy in elective office on the Borough Council of the Borough of Gettysburg unless he or she has resided within the Third Ward of the Borough of Gettysburg continuously for at least one (1) year immediately prior to his or her appointment; and

WHEREAS, the Borough Council of the Borough of Gettysburg desires to appoint an eligible, registered elector of the Third Ward of the Borough of Gettysburg to fill the vacancy in the office of member of Borough Council in the Third Ward of the Borough of Gettysburg due to the resignation from that elective office of AmyBeth Hodges. The person appointed to fill the aforesaid vacancy shall hold such office from the date of this resolution until the first Monday in January 2020, which is the date of the expiration of the term of office of AmyBeth Hodges as a member of the Borough Council in the Third Ward of the Borough of Gettysburg.

WHEREFORE, BE IT RESOLVED, that the Borough Council of the Borough of Gettysburg hereby appoints John D. Lawver as a member of the Borough Council of the Borough of Gettysburg in the Third Ward of the Borough of Gettysburg to fill the vacancy in elective office as a member of the Borough Council that

occurring by the resignation of AmyBeth Hodges until the first Monday in January 2020, which is January 6, 2020, the date of the expiration of the term of office of AmyBeth Hodges as a member of Borough Council in the Third Ward of the Borough of Gettysburg.


This appointment to the office of a member of Borough Council of the Borough of Gettysburg in the Third Ward of the Borough of Gettysburg is conditioned upon the receipt by the Borough of Gettysburg of a signed affidavit executed and delivered to the Borough Secretary by the aforesaid appointee stating and affirming under oath that: he or she is a registered elector of the Borough of Gettysburg, that he or she resides within the Third Ward of the Borough of Gettysburg, and that he or she has resided in the Third Ward of the Borough of Gettysburg continuously for at least one (1) year prior to his or her appointment.

This action is taken under and pursuant to the power of a borough council to appoint a registered elector of the borough to fill a vacancy in the elective borough ward office of a member of borough council as authorized pursuant to the Borough Code at 8 Pa. C.S.A. §901.
