

RESOLUTION NO. 133310-2

WHEREAS, on December 22, 2010, the Borough Council of the Borough of Gettysburg enacted and ordained Ordinance No. 1388-10 (hereinafter the "Ordinance") regulating towing and storage of damaged, abandoned, immobilized, disabled or illegally parked motor vehicles, said Ordinance being contained in Chapter 15, Part 6 of the Code of Ordinances of the Borough of Gettysburg; and

WHEREAS, pursuant to Section 605.C. and E. of the Ordinance, the Borough Council of the Borough of Gettysburg may by resolution establish fees for the issuance and renewal of towing licenses under the Ordinance; and

WHEREAS, pursuant to Section 610 of the Ordinance, the Borough Council of the Borough of Gettysburg may by resolution establish a schedule setting forth the maximum fees for the performance of towing and storage services under the Ordinance; and

WHEREAS, pursuant to Section 606 of the Ordinance, the Borough Council of the Borough of Gettysburg may by resolution set the minimum limit of liability insurance coverage for licensees under the Ordinance; and

WHEREAS, the Borough Council of the Borough of Gettysburg desires to adopt a resolution establishing the fees for the issuance and renewal of towing licenses, establishing a schedule for the maximum fees for the performance of towing and storage services under the Ordinance, and setting the minimum liability insurance coverage amounts of a licensee.


WHEREFORE, BE IT RESOLVED, that the Borough Council of the Borough of Gettysburg does hereby adopt the following fees for the issuance and renewal of licenses, the following maximum fees for the performance of towing and storage services, and the minimum liability insurance coverage requirements of licensees pursuant to the provisions of the Ordinance:

1. The fee for an original towing license application under the Ordinance shall be One Hundred (\$100.00) Dollars to be paid to the Borough at the time the application is submitted.
2. The fee for a towing license renewal application under the Ordinance shall be Fifty (\$50.00) Dollars to be paid to the Borough at the time the application for renewal is submitted.
3. The maximum fees to be charged by an authorized towing company for certain towing and storage services to be paid by the motor vehicle owner under the Ordinance shall be as follows:
 - a. The towing and removal of an immobilized or disabled motor vehicle or a motor vehicle parked in violation of any provision of any ordinance of the Borough as authorized and requested by the Borough consistent with the provisions of the Ordinance - \$75.00;


- b. The towing and removal of a motor vehicle which has been involved in a collision and the cleaning and removal of all debris from the collision area consistent with the provisions of the Ordinance - \$150.00 for the first hour and \$100.00 for each additional hour for towing and removal services performed pursuant to the Ordinance;
- c. The storage of any motor vehicle at a licensee's storage facilities consistent with the provisions of the Ordinance - \$75.00 per day which shall be computed on a 24-hour basis from the date and time of the towing of the motor vehicle from its location within the Borough until it is released to its owner pursuant to the Ordinance.
4. The minimum liability insurance policy limits to be carried by a licensee under the Ordinance shall be in the minimum amount of One Million (\$1,000,000.00) Dollars.
5. This Resolution shall be effective on the 1st day of January, 2011.
6. All other resolutions or parts of resolutions inconsistent herewith are hereby repealed.
7. The provisions of this Resolution may be amended according to law by a resolution duly adopted by the Borough Council of the Borough of Gettysburg and approved by the Mayor of the Borough of Gettysburg.
