

RESOLUTION NO. 111312-1

A RESOLUTION OF THE BOROUGH OF GETTYSBURG, ADAMS COUNTY, PENNSYLVANIA, APPOINTING YORK ADAMS TAX BUREAU AS THE DESIGNATED AGENT AND COLLECTOR OF ANY DELINQUENT EARNED INCOME AND NET PROFITS TAX ON BEHALF OF THE BOROUGH OF GETTYSBURG FOR ANY TAX YEARS PRIOR TO 2012.

WHEREAS, by Resolution adopted on April 10, 1978 and readopted on June 12, 1978, the Borough Council of the Borough of Gettysburg imposed a tax on earned income and net profits upon persons residing within the Borough of Gettysburg; and

WHEREAS, by Resolution adopted on August 8, 2005, the Borough Council of the Borough of Gettysburg appointed the York Adams Tax Bureau to serve as its designated agent and collector of Earned Income and New Profits Tax on behalf of the Borough of Gettysburg; and

WHEREAS, by Resolution adopted on June 9, 2008, the Borough Council of the Borough of Gettysburg appointed the Central Tax Bureau of Pennsylvania, Inc. ("Centax") as the designated agent and collector of the Earned Income Tax and Net Profits Tax on behalf of the Borough of Gettysburg, effective July 1, 2008, thereby replacing York Adams Tax Bureau as such designated agent and collector; and

WHEREAS, by Ordinance No. 1393-11, enacted on November 14, 2011, in order to comply with the Act of General Assembly of July 2008 (P.L. 197), known as Act No. 32, the Borough Council of the Borough of Gettysburg amended and readopted its Earned Income and Net Profits Tax and repealed any prior ordinances or resolution to the extent they were inconsistent with Ordinance No. 1393-11; and

WHEREAS, as required by Act No. 32, the Tax Collection Committee for the district in which the Borough of Gettysburg belongs designated the tax officer to administer and collect the Earned Income and Net Profits Tax, which designated tax officer is the York Adams Tax Bureau; and

WHEREAS, because Ordinance No. 1393-11 took effect on January 1, 2012, the York Adams Tax Bureau was not the designated agent and collector of Earned Income and Net Profits Tax for taxes prior to the effective date of that Ordinance; and

WHEREAS, Centax ceased to do business on or about September 21, 2012 and, therefore, ceased acting as the designated agent and collector on behalf of the Borough of Gettysburg of any delinquent earned income and net profits taxes for any tax years prior to January 1, 2012 during which tax years Centax was the designated agent and collector of said taxes; and

WHEREAS, the Borough Council of the Borough of Gettysburg desires to replace Centax with York Adams Tax Bureau as its designated agent and collector of its delinquent

Earned Income and Net Profits Tax on behalf of the Borough of Gettysburg for any tax years prior to January 1, 2012.

WHEREFORE, BE IT RESOLVED, that the Borough Council of the Borough of Gettysburg hereby appoints the York Adams Tax Bureau as its designated agent and collector of any delinquent Earned Income and Net Profits Tax on behalf of the Borough of Gettysburg to include any and all such delinquent taxes for any tax years prior to January 1, 2012.

THIS RESOLUTION DULY ADOPTED according to law on this 13th day of November, 2012, at a duly advertised meeting of the Borough Council of the Borough of Gettysburg.
