

RESOLUTION NO. 071210-2

RESOLUTION AUTHORIZING TRANSFER OF BOROUGH VEHICLE OF AN ESTIMATED FAIR MARKET VALUE OF FOUR HUNDRED TWENTY-FIVE DOLLARS (\$425.00) PURSUANT TO SECTION 1201(4)(ii) OF THE BOROUGH CODE.

WHEREAS, the Borough of Gettysburg is the owner of a 1995 Ford Crown Victoria unmarked police vehicle with an estimated fair market value of four hundred twenty-five dollars (\$425.00); and

WHEREAS, 53 P.S. § 46201(4)(ii), Section 1201(4)(ii) of The Borough Code, provides that a borough council shall have authority, by resolution, to dispose of surplus personal property of an estimated fair market value of less than one thousand dollars (\$1,000.00); and

WHEREAS, 53 P.S. § 46201(4)(iv)(A), Section 1201(4)(iv)(A) of The Borough Code provides that the requirement of advertising for bids or sale at public auction to the highest bidder does not apply where borough personal property is transferred to a volunteer fire department located within the borough; and

WHEREAS, the Borough Council of the Borough of Gettysburg believes that the transfer of said vehicle to the Gettysburg Fire Department will enable the Gettysburg Fire Department to better serve the needs of the citizens of Gettysburg and is in the best interests of the community as a whole; and

WHEREAS, the Borough Council of the Borough of Gettysburg desires to transfer said vehicle to the Gettysburg Fire Department for its official business use.

WHEREFORE, BE IT RESOLVED, that the Borough Council of the Borough of Gettysburg does hereby authorize the transfer of a 1995 Ford Crown Victoria (VIN 2FALP71W5SX157408) with an odometer reading of 157,910 miles to the Gettysburg Fire Department, a volunteer fire department existing, located and performing fire protection services within the Borough of Gettysburg.


BE IT FURTHER RESOLVED that John D. Butterfield, President of Borough Council and Sara L. Stull, Secretary be authorized to execute and deliver any documentation necessary to transfer and convey the vehicle to the Gettysburg Fire Department.

This action is taken under and pursuant to the power of the Borough Council of the Borough of Gettysburg to dispose of surplus personal property of an estimated fair market value of less than one thousand dollars (\$1,000.00) pursuant to in Section 1201(4)(ii) of The Borough Code and to transfer of such personal property to a


volunteer fire department within the Borough of Gettysburg without the advertising of bids or sale at public auction to the highest bidder pursuant to Section 1201(4)(iv)(A) of The Borough Code.

THIS RESOLUTION DULY ADOPTED according to law on this 12th day of July, 2010, at a duly advertised meeting of the Borough Council of the Borough of Gettysburg.
