**RESOLUTION OF THE BOROUGH COUNCIL OF THE
BOROUGH OF GETTYSBURG AUTHORIZING DISPOSAL OF
SURPLUS BOROUGH PERSONAL PROPERTY BY
ELECTRONIC AUCTION SALE PURSUANT TO SECTIONS
1201.2(a) AND 1201.2(a.1) OF THE BOROUGH CODE.**

WHEREAS, the Borough of Gettysburg is the owner of a 2004 Ford Crown Victoria unmarked police vehicle, in poor condition, with an estimated fair market value for fair condition of One Thousand Eight Hundred and Seventy-Three (\$1,873.00) Dollars; and

WHEREAS, the Borough of Gettysburg is the owner of a 2005 Ford Crown Victoria marked police vehicle, in poor condition, with an estimated fair market value for fair condition of Two Thousand Three (\$2,003.00) Dollars; and

WHEREAS, the Borough of Gettysburg is the owner of an Amano McGann pay-to-park automated parking system which consists of two (2) exit pay stations (AMG-6800 Series), four (4) gates/barriers and two (2) ticket dispensers with an estimated fair market value of Three Thousand Three Hundred (\$3,300.00) Dollars; and

WHEREAS, section 1201.2(a) of the Borough Code provides that where a borough council approves the disposal by sale of personal property that it estimates to have a fair market value of One Thousand (\$1,000.00) Dollars or more, the entire lot shall be advertised for sale once in at least one (1) newspaper of general circulation not less than ten (10) days prior to the date scheduled for the opening of bids or for the sale by public action; and

WHEREAS, section 1201.2(a.1) of the Borough Code provides for public auction of personal property conducted by means of an online or electronic auction sale, with the purchase price being paid by the highest bidder immediately or at a reasonable time after the conclusion of the electronic auction.

WHEREFORE, BE IT RESOLVED, by the Borough Council of the Borough of Gettysburg, Adams County, Pennsylvania, as follows:

1. The Borough Council of the Borough of Gettysburg does hereby authorize the listing and sale to the highest bidder by electronic auction sale of a 2004 Ford Crown Victoria (VIN: 2FAFP71W04X151371) with an odometer reading of 121,387 miles, in poor condition, with an estimated fair market value for such vehicle in fair condition of One Thousand Eight Hundred and Seventy-Three (\$1,873.00) Dollars. Said electronic auction sale shall be conducted through Municibid.com, a municipal auction website.

2. The Borough Council of the Borough of Gettysburg does hereby authorize the listing and sale to the highest bidder by electronic auction sale of a 2005 Ford Crown Victoria (VIN: 2FAFP71W35X136588) with an odometer reading of 122,056 miles, in poor condition,

with an estimated fair market value for such vehicle in fair condition of Two Thousand Three (\$2,003.00) Dollars. Said electronic auction sale shall be conducted through Municibid.com, a municipal auction website.

3. The Borough Council of the Borough of Gettysburg does hereby authorize the listing and sale to the highest bidder by electronic auction sale of an Amano McGann pay-to-park automated parking system, consisting of two (2) exit pay stations (AMG-6800 Series), four (4) gates/barriers and two (2) ticket dispensers with an estimated fair market value of Three Thousand Three Hundred (\$3,300.00) Dollars. Said electronic auction sale shall be conducted through Municibid.com, a municipal auction website.


4. The Borough Council of the Borough of Gettysburg does hereby authorize the advertisement of the sales by electronic auction consistent with sections 1201.2(a) and 1201.2(a.1) of the Borough Code, to include and provide the Internet address or means of accessing the electronic auction sales and the date, time and duration of the electronic auction sales.

BE IT FURTHER RESOLVED that Robert L. Krummerich, President of Borough Council, Charles R. Gable, MPA, Borough Manager and Sara L. Stull, Secretary, each be authorized to execute and deliver any documentation necessary to transfer and convey the aforesaid vehicles and personal property to the successful bidder or bidders.

This action is taken under and pursuant to the power of the Borough Council of the Borough of Gettysburg to dispose of personal property by electronic auction sale pursuant to sections 1201.2(a) and 1201.2(a.1) of the Borough Code.
