

**RESOLUTION NO. 020915-2**

**RESOLUTION APPROVING THE APPOINTMENT BY THE TAX COLLECTOR OF THE BOROUGH OF GETTYSBURG OF A DEPUTY TAX COLLECTOR.**

**WHEREAS**, the duly elected tax collector of the Borough of Gettysburg is charged with the collection and settling of taxes for the Borough of Gettysburg, the County of Adams and the Gettysburg Area School District; and

**WHEREAS**, section 22 of the Local Tax Collection Law (72 P.S. § 5511.22) allows a tax collector, with the approval of the taxing districts and of the surety of the tax collector, to deputize in writing one or more deputy tax collectors to serve during any incapacitation of the tax collector; and

**WHEREAS**, by Resolution No. 011215-2, adopted by the Borough Council of the Borough of Gettysburg on January 12, 2015, the Borough Council approved the appointment by Brian D. Eastman, the duly elected tax collector of the Borough of Gettysburg (hereinafter referred to as the "Borough Tax Collector"), of Mary M. Eastman as deputy tax collector, subject to written approval of the appointment by other taxing districts served by the Borough Tax Collector and subject to written approval by the surety of the Borough Tax Collector; and

**WHEREAS**, on January 27, 2015, the Borough Tax Collector appointed Lori L. Foltz, the duly elected tax collector for Berwick Township, as a deputy tax collector; and

**WHEREAS**, consistent with the aforesaid appointment of a deputy tax collector by the Borough Tax Collector, the Borough Council of the Borough of Gettysburg desires to approve his appointment of Lori L. Foltz as deputy tax collector to serve in the absence or incapacity of the Borough Tax Collector.

**WHEREFORE, BE IT RESOLVED**, that the Borough Council of the Borough of Gettysburg does hereby approve the appointment made by Brian D. Eastman, the duly elected tax collector for the Borough of Gettysburg, of Lori L. Foltz, the duly elected tax collector for Berwick Township, as a deputy tax collector:

**Deputy Tax Collector**. Lori L. Foltz, the duly elected tax collector for Berwick Township, deputized and appointed by Brian D. Eastman, the duly elected tax collector for the Borough of Gettysburg, shall be authorized to serve as deputy tax collector during the absence or incapacity of the said Borough Tax Collector. The appointment by the Borough Tax Collector of a deputy tax collector and the approval of said appointment by the Borough, as a taxing district, shall not relieve the Borough Tax Collector of his duty to account to the Borough of Gettysburg for all taxes received or collected by his deputies. The appointment of a deputy tax collector shall take effect following written approval of such appointment by the

other taxing districts served by the Borough Tax Collector and following written approval of such appointment by the surety of the Borough Tax Collector.

The provisions of this Resolution may be amended according to law by subsequent resolution duly adopted by the Borough Council of the Borough of Gettysburg.
