RESOLUTION OF THE BOROUGH COUNCIL OF THE BOROUGH OF GETTYSBURG AUTHORIZING TRANSFER OF TWO (2) BOROUGH VEHICLES PURSUANT TO SECTION 1201.3(a)(1) OF THE BOROUGH CODE.

WHEREAS, the Borough of Gettysburg is the owner of a 1995 Mercury Grand Marquis unmarked police vehicle, in poor condition, with an estimated fair market value for fair condition of One Thousand One Hundred Thirty-Nine (\$1,139.00) Dollars; and

WHEREAS, the Borough of Gettysburg is the owner of a 2001 Ford Taurus unmarked police vehicle, in poor condition, with an estimated fair market value for fair condition of One Thousand Six Hundred Thirty-Three (\$1,633.00) Dollars; and

WHEREAS, section 1201.3(a)(1) of the Borough Code provides that the requirement of advertising for bids or sale at public auction to the highest bidder does not apply where borough personal property is transferred to a school district; and

WHEREAS, the Borough Council of the Borough of Gettysburg believes that, in consideration of the poor condition of the vehicles, the transfer of said vehicles to the Gettysburg Area School District for use in connection with the School District's high school auto mechanic education program is beneficial to the community and is in the best interests of the Borough; and

WHEREAS, the Borough Council of the Borough of Gettysburg desires to transfer said vehicles to the Gettysburg Area School District for use in connection with the School District's high school auto mechanic education program.

WHEREFORE, BE IT RESOLVED, by the Borough Council of the Borough of Gettysburg, as follows:

- 1. The Borough Council of the Borough of Gettysburg does hereby authorize the transfer of a 1995 Mercury Grand Marquis (VIN: 2MELM75W1SX653589), in poor condition, with an estimated fair market value for such vehicle in fair condition of One Thousand One Hundred Thirty-Nine (\$1,139.00) Dollars to the Gettysburg Area School District for use in connection with the School District's high school auto mechanic education program.
- 2. The Borough Council of the Borough of Gettysburg does hereby authorize the transfer of a 2001 Ford Taurus (VIN: 1FAFP55U51A202851) with an odometer

reading of 102,368 miles, in poor condition, with an estimated fair market value for such vehicle in fair condition of One Thousand Six Hundred Thirty-Three (\$1,633.00) Dollars to the Gettysburg Area School District for use in connection with the School District's high school auto mechanic education program.

BE IT FURTHER RESOLVED that Michael J. Birkner, President of Borough Council and Sara L. Stull, Secretary be authorized to execute and deliver any documentation necessary to transfer and convey the aforesaid vehicles to the Gettysburg Area School District.

This action is taken under and pursuant to the power of the Borough Council of the Borough of Gettysburg to transfer personal property to a school district without the advertising of bids or sale at public auction to the highest bidder pursuant to 1201.3(a)(1) of the Borough Code.
