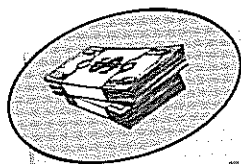

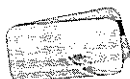

## GMA

The Gettysburg Municipal Authority has received 5 million dollars in grant funding under the **H2O PA Program** through the Commonwealth Financing Authority for costs associated with planned upgrades and improvements to the GMA public sewer system.

In addition, \$20,000 was awarded from Pennvest to institute a water conservation rain-barrel program and to improve the collection and treatment of sewage in part by eliminating residential illegal connections.

## GAS PIPELINE PROJECT BEGINS

As part of the PA Infrastructure Improvement Project, Columbia Gas has begun replacement of aging portions of its natural gas piping system in the Borough. The project began on South Washington Street and is being coordinated with the Borough and the Municipal Authority to maximize improvements to streets and sidewalks.

This is a long-term project to "ensure safe and reliable natural gas service." There are very few places in the Borough that will not be affected by this project which could include replacement of the service line to the home and/or individual gas meters.

The replacement will be completed in phases. Once all connections are made and testing completed, other contractors will replace the affected sidewalks and streets.

Customers will not be billed directly for this work. The resulting replacement of sidewalks, curbing and curb cuts by Columbia Gas will help the Borough in its effort to bring our sidewalks into compliance with the Americans with Disabilities Act requirements.

## RECREATIONAL COOPERATION PROGRAM



The Borough of Gettysburg, the Gettysburg Area School District and Cumberland, Franklin, Freedom, Mt. Joy, and Straban Townships are working cooperatively to create a regional recreation commission in order to provide a diverse array of recreation programs for area residents of all ages.

With funding from the PA Department of Conservation and Recreation, the municipalities and the school district are working with Peer Study Consultant and Director of the Lancaster Recreation Commission Sue Landes to craft an agreement which will avoid duplication of recreation services and combine efforts and resources to make the best use of facilities, like the Gettysburg Recreation Park. The goal is to offer an extensive schedule of recreational programs available to residents in a larger geographical area. A regional approach to recreation makes sense. It combines resources for the development of future facilities and the improvement and maintenance of existing facilities and provides recreation opportunities to meet the needs of a growing population. Ultimately, a regional approach will save money.

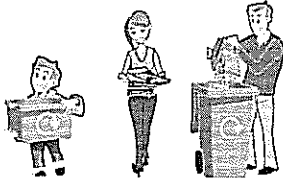

# NEW RECYCLING LIST

PLEASE KEEP FOR FUTURE REFERENCE



Waste Management has informed the Borough of Gettysburg that their recycling center is now located at Elkridge, MD.

This is important to you because this high-tech center can accept additional materials for recycling.

## The following should be placed in your recycle bin and can be mixed together (co-mingled):

(Items with an asterisk are **REQUIRED** by law to be recycled by Borough residents)

- \* Aluminum cans
- \* Newspapers (including all inserts) and junk mail
- \* Glass containers such as jars and bottles (remove lids and place in trash) Rinse carefully.
- \* Narrow-neck plastic containers (other than for motor oil) that carry plastic resin identification code 1 through 7 (bottles and jugs) Rinse carefully.

Brown paper bags

Magazines, catalogs, and telephone books

Cardboard, chipboard, and paperboard boxes, broken down to fit within the bin (including cereal boxes without liners, shoe boxes, etc.)

Magazines and catalogs

Colored paper

Computer printouts (clean paper)

Tin and steel cans Rinse carefully

Aerosol Cans (emptied of contents)

Office paper (including typing, fax, copy, letterhead, NCR) and envelopes

Non-metallic wrapping paper

Wide-mouth containers such as peanut butter, margarine/butter tubs, yogurt, cottage cheese, sour cream, mayonnaise, whipped topping, and **EMPTY** prescription bottles (please note that the lids and caps **do not** need to be removed). Rinse carefully.

Plastic flower pots Rinse carefully.

Aseptic/gable-top milk and juice cartons Rinse carefully.

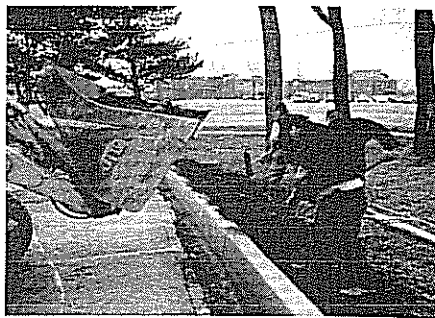

## NEW CURB, NEW ROOF, NEW PAINT

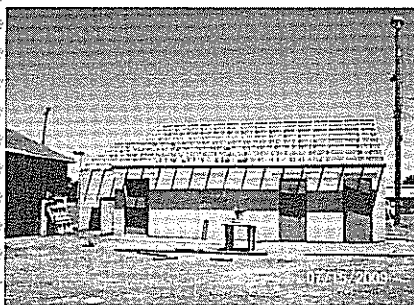
Thanks to a grant from the **Robert C Hoffman Charitable Endowment Trust**, the Borough Highway Department has installed curbing around the Rec Park's north parking area. This long-overdue improvement project was needed to remove a post and cable system that was a potential hazard especially to children running across the park.

This year another grant application was made to the Hoffman Trust to install additional similar curbing in the parking area along Long Lane.
