

RESOLUTION NO. 111323-3

A RESOLUTION OF THE BOROUGH COUNCIL OF THE BOROUGH OF GETTYSBURG, ADAMS COUNTY, PENNSYLVANIA, APPOINTING A MEMBER TO THE GETTYSBURG BOROUGH LOCAL HUMAN RELATIONS COMMISSION TO FILL A VACANCY ON THE COMMISSION.

WHEREAS, the Borough Council of the Borough of Gettysburg (hereinafter referred to as the “Borough Council”) adopted, enacted and ordained the Borough of Gettysburg Nondiscrimination and Local Human Relations Commission Ordinance, Ordinance No. 1475-20, on December 14, 2020, which is codified as Chapter 1, Part 13 of the Code of Ordinances of the Borough of Gettysburg (hereinafter referred to as the “Ordinance”); and

WHEREAS, pursuant to subsection 1-1307.1.A. of the Ordinance, the Borough Council appointed by resolution five (5) individuals as members of the Gettysburg Borough Human Relations Commission (hereinafter referred to also as the “Local Human Relations Commission”) to serve staggered and overlapping terms; and

WHEREAS, pursuant to Resolution No. 041221-1 adopted by the Borough Council on April 12, 2021, Jennie Dillon was appointed to serve as a member of the Local Human Relations Commission for a one (1) year term commencing on April 12, 2021 and expiring on April 15, 2022; and

WHEREAS, pursuant to Resolution No. 041122-2 adopted by the Borough Council on April 11, 2022, Jennie Dillon was appointed to serve as a member of the Local Human Relations Commission for a five (5) year term expiring on April 15, 2027; and

WHEREAS, due to the resignation of the said Jennie Dillon as a member of the Local Human Relations Commission, a vacancy has been created in the membership of the Commission; and

WHEREAS, pursuant to subsection 1-1307.1.A. of the Ordinance, the Borough Council is authorized and may appoint, by resolution, members of the Local Human Relations Commission and to make such appointments in order to fill vacancies on the Local Human Relations Commission for the unexpired portions of the terms of office of such members; and

WHEREAS, the Borough Council desires to appoint a member to the Local Human Relations Commission in order to fill the vacancy in such office created by the resignation of Jennie Dillon and to serve as a member of the Local Human Relations Commission for the remainder of the unexpired term of office of Ms. Dillon.

WHEREFORE, BE IT RESOLVED, that the Borough Council of the Borough of Gettysburg, Adams County, Pennsylvania, does hereby appoint Scott Wallace to the Gettysburg Borough Human Relations Commission in order to fill the vacancy in such office created by the resignation of Jennie Dillon and to serve as a member of the Commission for the remainder of the unexpired term of office of Ms. Dillon, which will expire on April 15, 2027.

This action is taken under and pursuant to the power of the Borough Council of the Borough of Gettysburg to appoint members to its Local Human Relations Commission pursuant to section 1-1307 of the Borough of Gettysburg Nondiscrimination and Local Human Relations Commission Ordinance.
