RESOLUTION APPROVING THE APPOINTMENT OF A DEPUTY TAX COLLECTOR BY THE TAX COLLECTOR OF THE BOROUGH OF GETTYSBURG, ADAMS COUNTY, PENNSYLVANIA.

WHEREAS, the duly elected tax collector of the Borough of Gettysburg is charged with the collection and settling of taxes of the taxpayers of the Borough of Gettysburg for the Borough, the County of Adams and the Gettysburg Area School District.

WHEREAS, section 22 of the Local Tax Collection Law (72 P.S. § 5511.22) allows a tax collector, with the approval of the taxing districts and of the surety of the tax collector, to deputize in writing one or more deputy tax collectors to serve during any incapacity of the tax collector; and

WHEREAS, Lisa A. Angstadt, who currently serves as the appointed tax collector of the Borough of Gettysburg, was duly elected as the Borough's tax collector in the municipal election held in November 2021 for a four (4) year term of office commencing on the first Monday in January 2022; and

WHEREAS, on November 18, 2021, the said Lisa A. Angstadt, in her capacity as the Borough's duly appointed and elected tax collector, appointed Donna J. Maring, the duly elected tax collector for Cumberland Township, as a deputy tax collector; and

WHEREAS, consistent with the aforesaid appointment of a deputy tax collector by the Borough's tax collector, the Borough Council of the Borough of Gettysburg desires to approve the appointment of Donna J. Maring as a deputy tax collector to serve in the incapacity of the said Borough's tax collector.

WHEREFORE, BE IT RESOLVED, that the Borough Council of the Borough of Gettysburg, Adams County, Pennsylvania, does hereby approve the appointment made by Lisa A. Angstadt, the Tax Collector for the Borough of Gettysburg (hereinafter the "Borough Tax Collector"). A true and correct copy of the Borough Tax Collector's Appointment of a Deputy Tax Collector Form is attached hereto as Exhibit "A."

Donna J. Maring, the Tax Collector for Cumberland Township, previously deputized and appointed by the Borough Tax Collector, shall be authorized to serve as deputy tax collector during the incapacity of the said Borough Tax Collector. The appointment by the Borough Tax Collector of a deputy tax collector and the approval of said appointment by the Borough, as a taxing district, shall not relieve the Borough Tax Collector of her duty to account to the Borough of Gettysburg for all taxes received or collected by her deputies. The

appointment of a deputy tax collector shall take effect following written approval of such appointment by the other taxing districts served by the Borough Tax Collector and following written approval of such appointment by the surety of the Borough Tax Collector.

The provisions of this Resolution may be amended according to law by subsequent resolution duly adopted by the Borough Council of the Borough of Gettysburg.
