

RESOLUTION NO. 010923-1

A RESOLUTION OF THE BOROUGH COUNCIL OF THE BOROUGH OF GETTYSBURG, ADAMS COUNTY, PENNSYLVANIA, AUTHORIZING THE BOROUGH OF GETTYSBURG, AS THE RESPONSIBLE ENTITY, TO CONDUCT AND SUBMIT A PART 58 ENVIRONMENTAL REVIEW TO THE U.S. DEPARTMENT OF HOUSING AND URBAN DEVELOPMENT ON BEHALF OF THE ADAMS COUNTY INDUSTRIAL DEVELOPMENT AUTHORITY (ACIDA), FOR THE COMMUNITY PROJECT FUNDING/CONGRESSIONALLY DIRECTED SPENDING GRANT, RECEIVED BY ACIDA FOR THE GETTYSBURG STATION REDEVELOPMENT PROJECT WITHIN THE BOROUGH OF GETTYSBURG.

WHEREAS, the Adams County Industrial Development Authority (hereinafter referred to as “ACIDA”) received a Community Project Funding/Congressionally Directed Spending (hereinafter referred to as “CPF”) grant for fiscal year 2022 for the Gettysburg Station Redevelopment Project within the Borough of Gettysburg; and

WHEREAS, according to the CPF Grant Guidelines, ACIDA cannot be classified as a Responsible Entity for purposes of conducting and submitting a U.S. Department of Housing and Urban Development (hereinafter referred to as “HUD”) Part 58 Environmental Review; and


WHEREAS, according to the CPF Grant Guidelines, the Borough of Gettysburg (hereinafter referred to as the “Borough”) may be classified as a Responsible Entity for such HUD Part 58 Environmental Review purposes; and

WHEREAS, the Borough, as a Responsible Entity, may conduct and submit the HUD Part 58 Environmental Review for the Gettysburg Station Rehabilitation Project.


WHEREFORE, BE IT RESOLVED, by the Borough Council of the Borough of Gettysburg, Adams County, Pennsylvania, that the Borough of Gettysburg will act as the Responsible Entity for the CPF grant, administered by HUD, and will conduct and submit a Part 58 Environmental Review, as required by the CPF grant.
