

RESOLUTION NO. 021422-1

WHEREAS, on March 14, 2011, the Borough Council of the Borough of Gettysburg (hereinafter the “Borough Council”) enacted Ordinance No. 1389-11 (hereinafter the “Special Events Ordinance”), which regulates the organization and conduct of special events within the Borough of Gettysburg (hereinafter the “Borough”); and

WHEREAS, pursuant to section 6-911 of the Special Events Ordinance, the Borough Council may establish and set from time to time, by adoption of a resolution, reasonable fees for the issuance of special events permits; and

WHEREAS, on December 13, 2021, the Borough Council adopted Resolution No. 121321-3 to establish, amend, update and confirm the amounts of various fees and costs related to certain activities to include special events conducted within the Borough in 2022; and

WHEREAS, consistent with input from the Borough community, including sponsors and organizers of parades, and resulting discussions regarding the same, the Borough Council finds that it is in the best interests of the Borough, its residents, community members and visitors to establish certain fixed special event permit fees for parades using certain designated parade routes within the Borough; and

WHEREAS, the use of designated parade routes with fixed permit fees will enable sponsors and organizers of parades to plan and budget for such parades in accordance with a selected route and associated permit fee and will enable the Borough to streamline its permitting process and more efficiently determine necessary Borough staff coverage for the parade based on the use of a designated route.

WHEREFORE, BE IT RESOLVED, that the Borough Council of the Borough of Gettysburg, Adams County, Pennsylvania, hereby amends Resolution No. 121321-3, the Borough’s fee resolution for fiscal year 2022, for the purpose of establishing and setting special event permit fees for the conduct of parades, based upon the use of certain designated parade routes within the Borough of Gettysburg, pursuant to the Borough’s Special Events Ordinance, as follows:

1. **Special Events (Parades – Designated Routes) –**

a. The fee for a special event permit for designated parade routes, exclusive of the required application fee, shall be established and set as follows:


1. Medium parade route (traditional Halloween parade route) - \$4,954.00
2. Long parade route A (traditional Memorial Day parade route) - \$3,978.00
3. Long parade route B (traditional Remembrance Day parade route) - \$5,569.00

Each of the aforesaid designated parade routes is depicted on Exhibit “A” which is attached hereto and incorporated herein by the reference.

2. Resolution No. 121321-3, adopted by the Borough Council on December 13, 2021, except as amended herein, shall remain in full force and effect. All other resolutions or parts of resolutions inconsistent herewith are hereby amended and revised by this resolution.

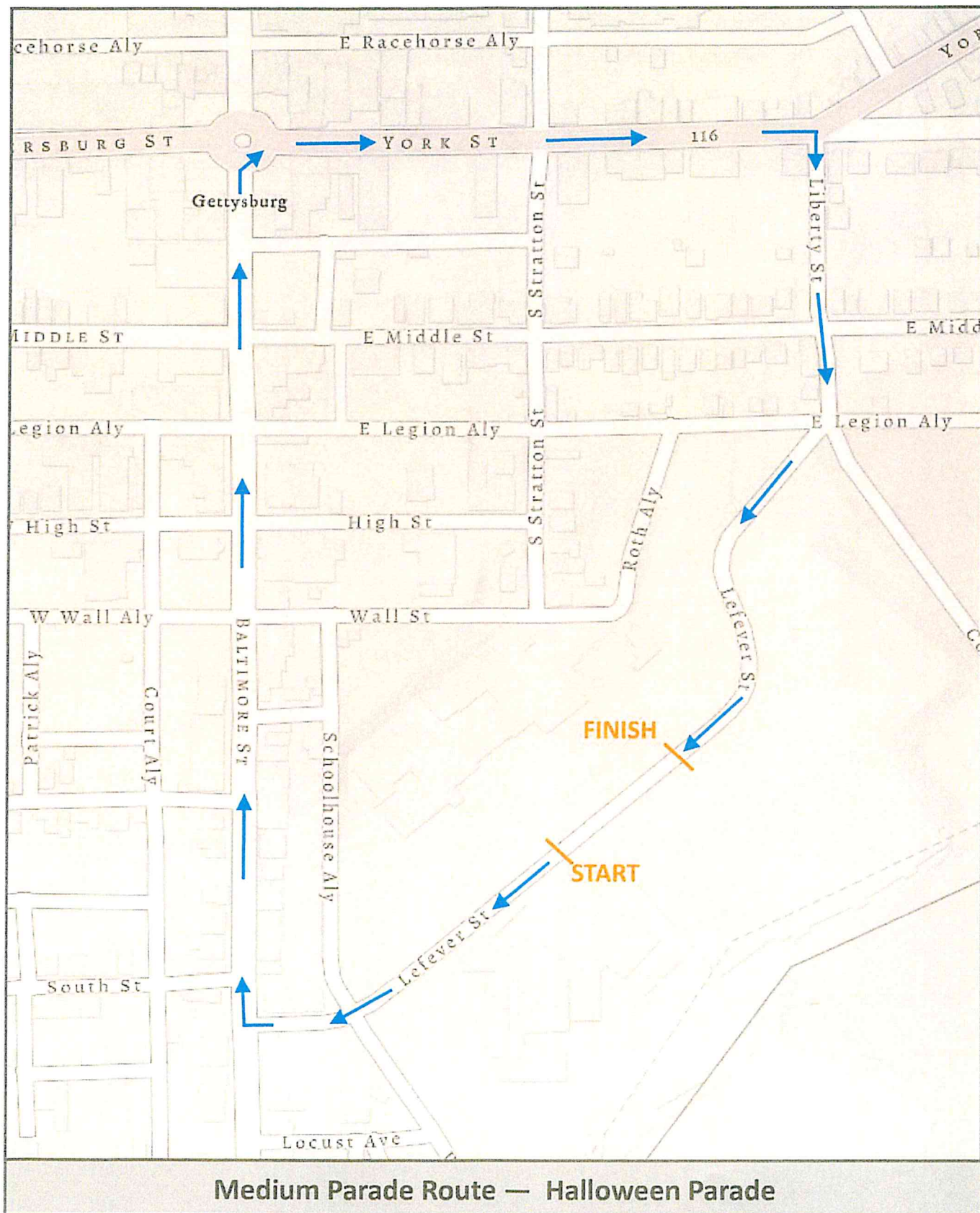
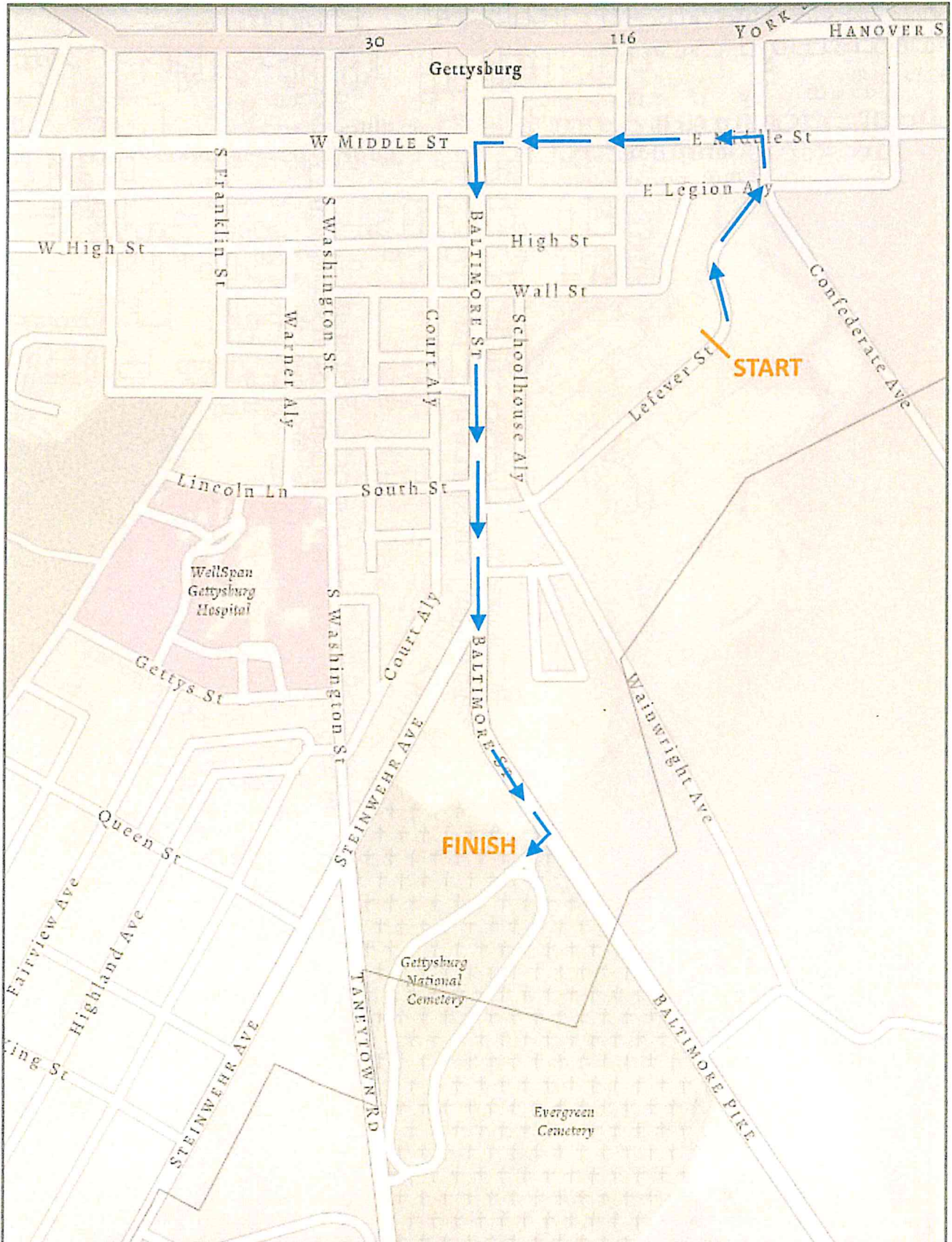
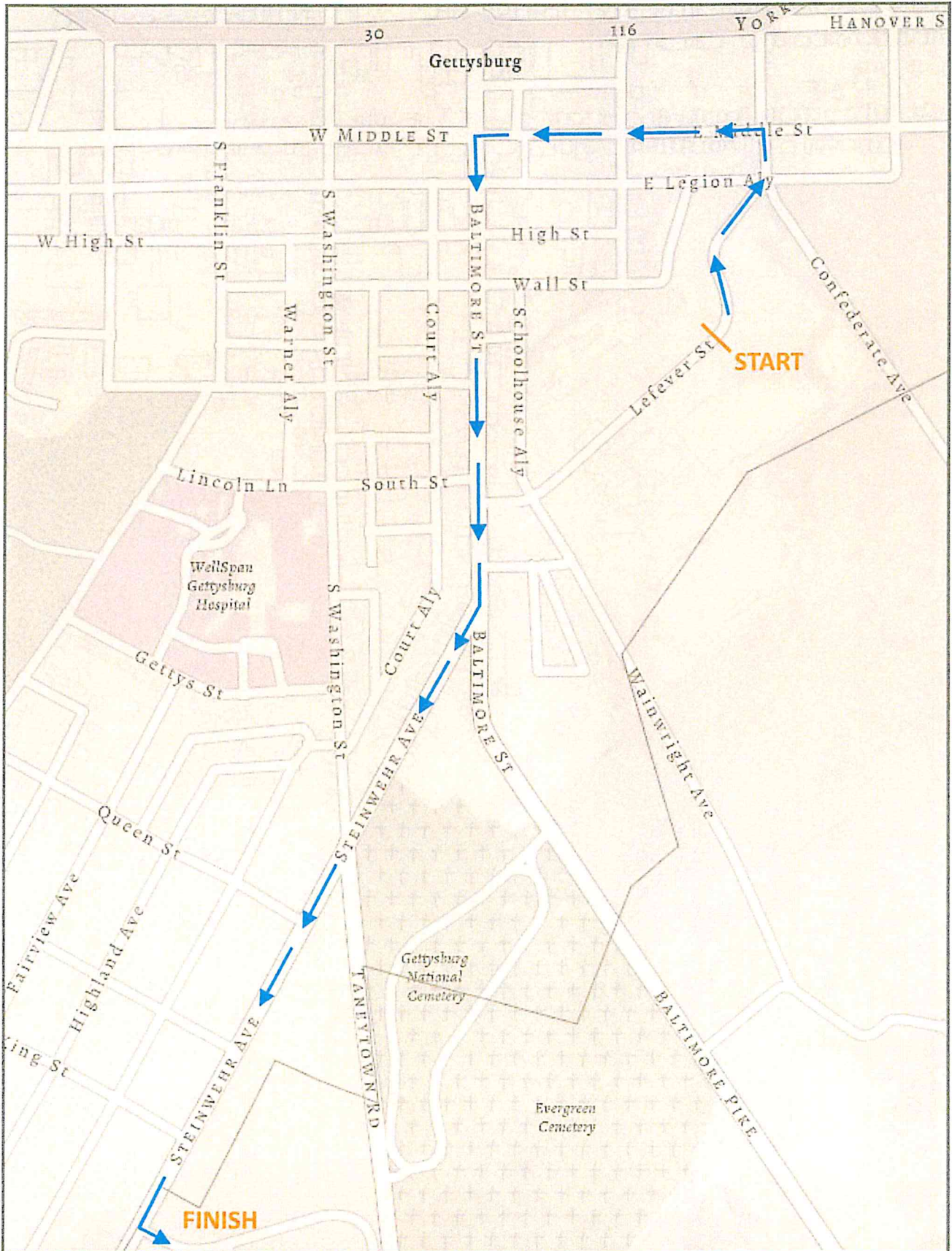
