

**RESOLUTION NO. 041023-2**

**A RESOLUTION OF THE BOROUGH COUNCIL OF THE BOROUGH OF GETTYSBURG, ADAMS COUNTY, PENNSYLVANIA, APPOINTING A MEMBER TO THE GETTYSBURG BOROUGH LOCAL HUMAN RELATIONS COMMISSION FOR A TERM OF FIVE (5) YEARS.**

**WHEREAS**, the Borough Council of the Borough of Gettysburg (hereinafter referred to as the “Borough Council”) adopted, enacted and ordained the Borough of Gettysburg Nondiscrimination and Local Human Relations Commission Ordinance, Ordinance No. 1475-20, on December 14, 2020, which is codified as Chapter 1, Part 13 of the Code of Ordinances of the Borough of Gettysburg (hereinafter referred to as the “Ordinance”); and

**WHEREAS**, pursuant to subsection 1-1307.1.A. of the Ordinance, the Borough Council initially appointed, by adoption of Resolution No. 041221-1, five (5) individuals as members of the Gettysburg Borough Human Relations Commission (hereinafter referred to also as the “Local Human Relations Commission”) to serve staggered and overlapping terms; and

**WHEREAS**, pursuant to subsection 1-307.1.A. of the Ordinance, the terms of office of the members of the Local Human Relations Commission shall be five (5) years, and the terms of office shall be so fixed that the term of office of one member of the Commission shall expire each year and members of the Commission may succeed themselves; and

**WHEREAS**, pursuant to Resolution No. 041221-1, adopted by the Borough Council on April 12, 2021, Janelle Wertzberger was appointed to serve as a member of the Local Human Relations Commission for an initial two (2) year staggered term commencing on April 12, 2021 and expiring on April 15, 2023; and


**WHEREAS**, due to the expiration of the term of Ms. Wertzberger on April 15, 2023, the Borough Council desires to appoint her to serve again and to succeed herself as a member of the Local Human Relations Commission for a five (5) year term of office expiring on April 15, 2028.

**WHEREFORE, BE IT RESOLVED**, that the Borough Council of the Borough of Gettysburg, Adams County, Pennsylvania, does hereby appoint Janelle Wertzberger as a member of the Gettysburg Borough Human Relations Commission in order to succeed herself and to serve for a five (5) year term of office expiring on April 15, 2028.

This action is taken under and pursuant to the power of the Borough Council of the Borough of Gettysburg to appoint members to its Local Human Relations Commission pursuant to section 1-1307 of the Borough of Gettysburg Nondiscrimination and Local Human Relations Commission Ordinance.
