

RESOLUTION NO. 050823-4

**A RESOLUTION OF THE BOROUGH COUNCIL OF THE
BOROUGH OF GETTYSBURG, ADAMS COUNTY,
PENNSYLVANIA, APPOINTING A MEMBER TO THE CODE
ENFORCEMENT APPEALS BOARD OF THE BOROUGH OF
GETTYSBURG, ADAMS COUNTY, PENNSYLVANIA, FOR THE
REMAINDER OF A FIVE (5) YEAR TERM EXPIRING ON
MARCH 15, 2027.**

WHEREAS, the Borough Council of the Borough of Gettysburg (hereinafter referred to as the “Borough Council”) adopted, enacted and ordained its Code Enforcement Appeals Board Ordinance (Ordinance No. 1372-10) on March 8, 2010, which is codified as Chapter 1, Part 6, Subpart C of the Code of Ordinances of the Borough of Gettysburg (hereinafter referred to as the “Ordinance”); and

WHEREAS, pursuant to section 1-623 of the Ordinance, the Borough Council shall appoint by resolution five (5) resident property owners of the Borough as members of the Code Enforcement Appeals Board of the Borough of Gettysburg (hereinafter referred to as the “Appeals Board”) with staggered terms fixed so that the term of office of one (1) member shall expire each year; and

WHEREAS, pursuant to Resolution No. 111219-1 adopted on November 12, 2019, Jon Murdoch was appointed as a member of the Appeals Board by the Borough Council in order to serve for the remainder of a previously vacated five (5) year term of office, which term was set to expire on March 15, 2022; and

WHEREAS, due to the expiration of the term of Jon Murdoch as a member of the Appeals Board without the appointment of a new member to replace him, Mr. Murdoch remains as a member of said Appeals Board until such time as either a successor is appointed to the Board or Mr. Murdoch is appointed to succeed himself as a member of the Board; and

WHEREAS, the Borough Council desires to confirm the continued service of Jon Murdoch as a member of the Appeals Board and to appoint Mr. Murdoch to the Appeals Board in order to continue to serve and to succeed himself as a member of the Board for the remainder of a five (5) year term of office, which term will expire on March 15, 2027.


WHEREFORE, BE IT RESOLVED, that the Borough Council of the Borough of Gettysburg hereby appoints Jon Murdoch, a resident property owner of the Borough of Gettysburg, to serve as a member of the Code Enforcement Appeals Board in order to succeed

himself and to serve and complete the remainder of a five (5) year term of office expiring on March 15, 2027.

This action is taken under and pursuant to the power of the Borough Council of the Borough of Gettysburg to appoint resident property owners of the Borough of Gettysburg to serve as members of its Code Enforcement Appeals Board pursuant to section 1-623 of the Code Enforcement Appeals Board Ordinance.
