## **RESOLUTION NO. 051319-1**

WHEREAS, by Resolution No. 121018, adopted by the Borough Council of the Borough of Gettysburg on December 10, 2018, the Borough Council established, amended, updated or confirmed certain Borough of Gettysburg fees, to include fees for the temporary reservation of parking spaces by use of meter bags and for the placement of open-top refuse containers; and

WHEREAS, by Ordinance No. 1459-19, enacted by the Borough Council of the Borough of Gettysburg on April 8, 2019, the Borough Council amended the provisions relative to temporary reservation of unmetered and metered parking spaces, to include the addition of provisions in section 702 and section 712 of the ordinance that fees shall be established, set or amended by resolution to be adopted from time to time by the Borough Council, which language is consistent with other references in the Borough's Code of Ordinances. Section 711 and section 722 of Chapter 15, Part 7 of the Code of Ordinances of the Borough of Gettysburg, respectively relating to the setting of fees by resolution for the temporary reservation of parking spaces by use of meter bags and for the placement of opentop refuse containers, were in effect on December 10, 2018, and accordingly the corresponding fees were properly set by Resolution No. 121018. Such fees are intended to be confirmed herein for purposes of clarity as to all of the fees to be charged by the Borough of Gettysburg under Chapter 15, Part 7 of the Code of Ordinances of the Borough of Gettysburg; and

WHEREAS, the Borough Council desires to set and confirm the Borough's fees and charges for the issuance of any reservations of public parking spaces pursuant to sections 15-702, 15-711, 15-712 and 15-722 of the Code of Ordinances of the Borough of Gettysburg; and

WHEREFORE, BE IT RESOLVED, that the Borough Council of the Borough of Gettysburg, Adams County, Pennsylvania, does hereby set, establish and confirm the following fees:

<u>Temporary Reserved Parking Space in Unmetered Zones</u> – The fees for the temporary reservation of a parking space in an unmetered zone, are and shall be as follows:

- 1. An hourly rate of One (\$1.00) Dollar.
- 2. A daily rate of Twelve (\$12.00) Dollars.
- 3. A monthly rate of One Hundred (\$100.00) Dollars.

Temporary Reserved Parking Space Via Meter Bag – The fees for the temporary reservation of a parking space in a metered zone via meter bag placement, where hourly rates are indicated, are and shall be as follows:

- 1. For hourly rates of One Dollar and Fifty Cents (\$1.50):
  - a. A daily rate of Eighteen (\$18.00) Dollars.
  - b. A monthly rate of One Hundred Fifty (\$150.00) Dollars.
- 2. For hourly rates of One (\$1.00) Dollar:
  - a. A daily rate of Twelve (\$12.00) Dollars.
  - b. A monthly rate of One-Hundred (\$100.00) Dollars.

<u>Open-Top Refuse Containers</u> - The fee for placement of open-top refuse containers in unmetered or metered parking zones is confirmed to be Fifty (\$50.00) Dollars per week.

All other resolutions or parts of resolutions inconsistent herewith are hereby amended and revised by this Resolution.
