**A RESOLUTION OF THE BOROUGH COUNCIL OF THE
BOROUGH OF GETTYSBURG, ADAMS COUNTY,
PENNSYLVANIA, RATIFYING AND CONFIRMING THE
RESCISSION OF THE COVID-19 DECLARATION OF
MANDATORY CURFEW.**

WHEREAS, consistent with section 7501 of the Pennsylvania Emergency Management Services Code (35 Pa. C.S.A. § 7501) governing general authority of political subdivisions relative to health and safety, on March 16, 2020, Theodore H. Streeter, Mayor of the Borough of Gettysburg, issued and proclaimed a Declaration of Disaster Emergency authorizing the taking of all appropriate measures in order to facilitate the Borough's coordination with other agencies and its necessary and appropriate response to the ongoing threat of COVID-19, which Declaration of Disaster Emergency was ratified, continued and extended by the Borough Council of the Borough of Gettysburg by Resolution No. 031920 dated March 19, 2020 and was further continued and extended by Resolution No. 042720-2 dated April 27, 2020; and

WHEREAS, consistent with Adams County's movement into the COVID-19 "Yellow Phase" pursuant to Governor Wolf's Process to Reopen Pennsylvania, on June 3, 2020, Theodore H. Streeter, Mayor, rescinded the Declaration of Mandatory Curfew, originally issued on April 2, 2020.

WHEREFORE, BE IT RESOLVED, that the Borough Council of the Borough of Gettysburg, Adams County, Pennsylvania, does hereby ratify and confirm, effective June 3, 2020, the rescission of the Declaration of Mandatory Curfew, originally issued by Mayor Theodore H. Streeter on April 2, 2020; and

WHEREFORE, BE IT FURTHER RESOLVED, that the Declaration of Disaster Emergency, originally issued by Mayor Theodore H. Streeter on March 16, 2020, as ratified, continued and extended by Resolution No. 031920 dated March 19, 2020 and as further continued and extended by Resolution No. 042720-2 dated April 27, 2020, shall remain in full force and effect within the Borough of Gettysburg.

This action is taken under and pursuant to the provisions of section 7501 of the Pennsylvania Emergency Management Services Code (35 Pa. C.S.A. § 7501) governing general authority of political subdivisions relative to health and safety and emergency management services.

This action is also taken consistent with and pursuant to the provisions of section 10A06 of the Borough Code (8 Pa. C.S.A. § 10A06) relative to the general powers granted to the mayor of a borough in the event of a state of emergency.

THIS RESOLUTION DULY ADOPTED according to law on this 8th day of June, 2020, at a duly advertised monthly general business meeting of the Borough Council of the Borough of Gettysburg, Adams County, Pennsylvania.
