

**A RESOLUTION OF THE COUNCIL OF THE BOROUGH OF GETTYSBURG, ADAMS COUNTY, PENNSYLVANIA,  
AUTHORIZING THE BOARD OF COMMISSIONERS OF ADAMS COUNTY TO SUBMIT AN APPLICATION FOR 2020  
COMMUNITY DEVELOPMENT BLOCK GRANT - CARES FUNDS TO THE PENNSYLVANIA DEPARTMENT OF COMMUNITY  
AND ECONOMIC DEVELOPMENT ON BEHALF OF THE BOROUGH OF GETTYSBURG**

**WHEREAS**, the County of Adams, in accordance with Pennsylvania Act 179 and the Federal CARES Act of 2020, has elected to submit an application for the 2020 Community Development Block Grant – CARES (CDBG-CV) Program; and

**WHEREAS**, the Borough of Gettysburg desires to participate in the CDBG-CV Program for 2020 in accordance with Act 179; and

**WHEREAS**, the Pennsylvania Department of Community and Economic Development has notified the Borough of Gettysburg that its 2020 CDBG-CV allocation is \$70,413; and

**WHEREAS**, the Borough of Gettysburg, has examined the community development needs of the Borough, especially of lower income residents; and

**WHEREAS**, the Borough of Gettysburg has established a Community Development Program and budget for its 2020 CDBG-CV Program in compliance with the allocation and guidelines of the Pennsylvania Department of Community and Economic Development; and

**WHEREAS**, applications are due at the Pennsylvania Department of Community and Economic Development on July 31, 2020; and

**WHEREAS**, the Borough of Gettysburg has designated the Adams County Office of Planning and Development as the Borough's administrating agency for its CDBG Program.

**NOW, THEREFORE, BE IT RESOLVED**, by the Council of the Borough of Gettysburg that the following Community Development Program and budget be communicated to the Board of Commissioners of Adams County for inclusion in the County's 2020 CDBG-CV Program on behalf of the Borough of Gettysburg for the following projects:

- Grants for Businesses Impacted by COVID-19 Meeting the Urgent Need National Objective: \$19,000; and
- Grants for Businesses Impacted by COVID-19 Meeting the LMI National Objective: \$46,000; and
- Administration \$5,413
