

RESOLUTION NO. 070819-1

**RESOLUTION AUTHORIZING THE DISPOSAL AND SALES OF
BOROUGH OF GETTYSBURG POLICE DEPARTMENT
SURPLUS PERSONAL PROPERTY OF AN ESTIMATED FAIR
MARKET VALUE OF LESS THAN TWO THOUSAND
DOLLARS (\$2,000.00) PURSUANT TO SECTION 1201.2 OF
THE BOROUGH CODE.**

WHEREAS, the Borough of Gettysburg Police Department (the "Police Department") owns certain older surplus model TASER devices and accessory equipment that are outdated and no longer suitable for law enforcement use by the Police Department; and

WHEREAS, consistent with subsection 1201.2 of the Borough Code (8 Pa C.S.A. §1201.2), the Borough Council may approve, by resolution, the sale of surplus personal property, either individual items or lots of items, of an estimated fair market value of less than two thousand dollars (\$2,000.00); and

WHEREAS, the Police Department has procured an estimate of the fair market value for each of the surplus TASER devices and accessory equipment which items of surplus personal property consist of five (5) TASER X26 models, one (1) TASER X2 model and twenty-five (25) TASER X2 cartridges; and

WHEREAS, because of the nature of the surplus personal property, the Police Department may only sell the same to others within the law enforcement community. In that regard, the Police Department has made arrangements with the Adams County Constable Association, a nonprofit law enforcement organization, to purchase the bulk of the items of personal property being offered for sale. An estimate of fair market value of the surplus TASER devices and accessory equipment to be disposed of and sold to the Adams County Constable Association is attached hereto as Exhibit "A" and is incorporated herein by reference; and

WHEREAS, the Police Department has also made arrangements with Shannon J. Hilliard, a Patrol Officer First Class in the Police Department who provides law enforcement TASER training and instruction, to purchase one (1) TASER X26 model. An estimate of fair market value of the surplus TASER device to be disposed of and sold to Shannon J. Hilliard is attached hereto as Exhibit "B" and is incorporated herein by reference.

WHEREFORE, BE IT RESOLVED, that the Borough Council of the Borough of Gettysburg does hereby authorize the disposal and sale of the surplus TASER devices and equipment, as identified on Exhibit "A," for the sum of one


thousand eight hundred fifty (\$1,850.00) dollars to the Adams County Constable Association, a nonprofit law enforcement organization, consistent with the estimate of fair market value for the TASER devices and equipment as procured by the Police Department.

WHEREFORE, BE IT FURTHER RESOLVED, that the Borough Council of the Borough of Gettysburg does hereby authorize the disposal and sale of one (1) surplus TASER X26 model device, as identified on Exhibit "B," for the sum of one hundred fifty (\$150.00) dollars to Shannon J. Hilliard, a Patrol Officer First Class in the Police Department who provides law enforcement TASER training and instruction, consistent with the estimate of fair market value for the surplus TASER X26 model device as procured by the Police Department.

These actions are taken under and pursuant to the power of the Borough Council of the Borough of Gettysburg to dispose of and sell surplus personal property, either in lots of items or individual items, of an estimated fair market value of less than two thousand dollars (\$2,000.00) as found in subsection 1201.2 of the Borough Code.

THIS RESOLUTION DULY ADOPTED according to law on this 8th day of July, 2019 at a duly advertised general monthly business meeting of the Borough Council of the Borough of Gettysburg, Adams County, Pennsylvania.
