## **RESOLUTION NO. 071023-2**

A RESOLUTION OF THE BOROUGH COUNCIL OF THE BOROUGH OF GETTYSBURG, ADAMS COUNTY, PENNSYLVANIA, IMPLEMENTING AN OVERSIZED VEHICLE PARKING PILOT PROGRAM IN DESIGNATED LOCATIONS WITHIN THE BOROUGH OF GETTYSBURG.

WHEREAS, Chapter 15, Part 1, section 15-105 of the Code of Ordinances of the Borough of Gettysburg provides that the Borough Council of the Borough of Gettysburg (hereinafter referred to as the "Borough Council") may, from time to time by resolution, and for a period of not more than ninety (90) days, implement specific traffic and/or parking regulations, prohibitions and restrictions at designated locations within the Borough of Gettysburg (hereinafter referred to as the "Borough"); and

WHEREAS, the Gettysburg Borough Parking Department (hereinafter referred to as the "Parking Department"), at the direction of the Borough Council, has reviewed and considered the suitability of various locations within the Borough for designated oversized vehicle parking; and

WHEREAS, based on its findings, the Parking Department has recommended that the Borough Council implement a pilot program for nine (9) designated oversized vehicle parking spaces in locations along Baltimore Street, York Street, Carlisle Street, Long Lane and Steinwehr Avenue.

WHEREFORE, BE IT RESOLVED, that the Borough Council of the Borough Gettysburg, Adams County, Pennsylvania, does hereby implement the aforesaid oversized vehicle parking pilot program and does hereby designate the following streets and areas for the location of parking spaces for oversized vehicles:

Street	Side	Between
Baltimore Street	East	Wade Avenue and Lefever Street
Baltimore Street	West	Breckenridge Street and South Street
Carlisle Street	East	East Water Street and Stevens Street
Carlisle Street	West	West Water Street and Stevens Street
Long Lane (2 parking spaces)	Southwest	Gettys Street and Breckenridge Street

Steinwehr Avenue Southwest Queen Street and South Washington Street

York Street South South Stratton Street and Liberty Street

York Street North North Stratton Street and Route 30

WHEREFORE, BE IT FURTHER RESOLVED, that the oversized vehicle parking space locations shall be designated by appropriate signage.

Payment for parking of oversized vehicles in connection with the pilot program shall be at the rate of three (\$3.00) dollars per hour.

Penalties for violations of regulations in designated oversized vehicle parking locations shall be consistent with fines and penalties established for violations of onstreet payment parking as contained in Chapter 15, Part 4 of the Code of Ordinances of the Borough of Gettysburg.

The designated oversized vehicle parking pilot program, as authorized herein, shall take effect and be implemented in July 2023 and shall terminate in October 2023.
