

RESOLUTION NO. 071320-3

**A RESOLUTION OF THE BOROUGH COUNCIL OF THE
BOROUGH OF GETTYSBURG, ADAMS COUNTY,
PENNSYLVANIA, IMPLEMENTING AN “APP-ONLY PARKING
ZONES” PILOT TESTING PROGRAM ON A PORTION OF
WEST BROADWAY STREET AND ON A PORTION OF WEST
LINCOLN AVENUE.**

WHEREAS, Chapter 15, Part 1, section 15-105 of the Code of Ordinances of the Borough of Gettysburg provides that the Borough Council of the Borough of Gettysburg (hereinafter referred to as the “Borough Council”) may, from time to time by resolution, and for a period of not more than ninety (90) days, implement specific traffic and/or parking regulations, prohibitions and restrictions at designated locations within the Borough of Gettysburg (hereinafter referred to as the “Borough”); and

WHEREAS, the Gettysburg Borough Parking Department (hereinafter referred to as the “Parking Department”), at the direction of the Borough Council, has reviewed and considered the suitability of various locations within the Borough for the additional placement of parking meters; and

WHEREAS, based on its findings, the Parking Department has recommended that the Borough Council implement a pilot testing program utilizing “app-only parking zones” as a more cost-effective alternative to adding parking meters with designated locations in the third block of West Lincoln Avenue and in the third block of West Broadway Street.

WHEREFORE, BE IT RESOLVED, that the Borough Council of the Borough of Gettysburg, Adams County, Pennsylvania, does hereby designate the following areas as app-only parking zones:

Street	Side	Between
West Broadway Street (Third block only)	Both	College Avenue and its terminus
West Lincoln Avenue (Third block only)	South	College Avenue and Constitution Avenue

WHEREFORE, BE IT FURTHER RESOLVED, that the app-only parking zones on the third block of West Broadway Street and the third block of West Lincoln Avenue shall be designated by appropriate signage.


Penalties for violations of regulations in designated app-only parking zones shall be consistent with fines and penalties established for violations of on-street metered parking as contained in Chapter 15, Part 4 of the Code of Ordinances of the Borough of Gettysburg.

The app-only parking zones as authorized herein shall take effect on July 15, 2020 and shall terminate on October 14, 2020

THIS RESOLUTION DULY ADOPTED according to law on this 13th day of July, 2020, at a duly advertised monthly general business meeting of the Borough Council of the Borough of Gettysburg, Adams County, Pennsylvania.
