

RESOLUTION NO. 081219-1

**A RESOLUTION OF THE BOROUGH COUNCIL OF THE
BOROUGH OF GETTYSBURG, ADAMS COUNTY,
PENNSYLVANIA, AUTHORIZING THE SALE OF
GETTYSBURG BOROUGH SURPLUS PERSONAL PROPERTY
TO THE CITY OF YORK, PENNSYLVANIA, PURSUANT TO
SECTION 1201.2 AND SECTION 1201.3 OF THE BOROUGH
CODE.**

WHEREAS, the Borough of Gettysburg (the "Borough") owns certain surplus personal property comprised of parking equipment, to include parking gate arms and miscellaneous parking gate equipment and supplies, which personal property has been replaced and is no longer in use by the Borough at its parking garage and facility located on Racehorse Alley; and

WHEREAS, consistent with section 1201.2 of the Borough Code (8 Pa C.S.A. §1201.2), the Borough Council may approve, by resolution, the sale of surplus personal property, either individual items or lots of items, of an estimated fair market value of less than two thousand dollars (\$2,000.00); and

WHEREAS, consistent with section 1201.3 of the Borough Code (8 Pa C.S.A. §1201.3), the advertisement for bids or sale at public auction shall not be required for the sale of borough personal property to a county, city, borough, town, township, institution district, school district, volunteer fire company, volunteer ambulance service or volunteer rescue squad located within the borough; and


WHEREAS, the City of York, Pennsylvania, has agreed to purchase the Borough's aforesaid parking equipment for the sum of one thousand dollars (\$1,000.00) which is the estimated fair market value of the surplus personal property.

WHEREFORE, BE IT RESOLVED, that the Borough Council of the Borough of Gettysburg, Adams County, Pennsylvania, does hereby authorize the disposal and sale of surplus personal property comprised of certain Borough parking equipment, to include parking gate arms and miscellaneous parking gate equipment and supplies, to the City of York, Pennsylvania, for its estimated fair market value, the sum of one thousand dollars (\$1,000.00). The surplus personal property is identified on the invoice which is attached hereto as Exhibit "A" and is incorporated herein by reference.

This action is taken under and pursuant to the power of the Borough Council of the Borough of Gettysburg to dispose of surplus personal property of an estimated fair market value of less than two thousand dollars (\$2,000.00) pursuant to section 1201.2 of the Borough Code and to sell such personal property to a city of the Commonwealth of the Pennsylvania, without the advertisement for bids or the sale of such personal property at public auction to the highest bidder, consistent with section 1201.3(a) of the Borough Code.

THIS RESOLUTION DULY ADOPTED according to law on this 12th day of August, 2019, at a duly advertised general monthly business meeting of the Borough Council of the Borough of Gettysburg, Adams County, Pennsylvania.
