

RESOLUTION NO. 082321

WHEREAS, Jacob W. Schindel was duly elected in the municipal election held on November 5, 2019, and Mr. Schindel subsequently qualified as a member at-large of the Borough Council of the Borough of Gettysburg for a four (4) year term of office which term commenced on the first Monday of January 2020 and will expire on January 2, 2024; and

WHEREAS, on July 26, 2021, Jacob W. Schindel announced his intention to resign as a member at-large of the Borough Council of the Borough of Gettysburg due to the termination of his residency from the Borough of Gettysburg. His resignation from that elective office was accepted by a majority vote of a quorum of the Borough Council at the conclusion of a duly advertised general monthly business meeting of the Borough Council which was held on August 9, 2021; and

WHEREAS, as a result of the termination of residency from the Borough of Gettysburg of Jacob W. Schindel and his resignation as a member at-large of the Borough Council, a vacancy in such elective office has occurred effective at the conclusion of the monthly general business meeting of the Borough Council held on August 9, 2021, when the resignation was formally accepted by a majority vote of the Borough Council; and

WHEREAS, consistent with the provisions of the Borough Code at 8 Pa. C.S.A. §901, the Borough Council of the Borough of Gettysburg shall fill the vacancy in the elective office of a member of Borough Council within thirty (30) days of such vacancy by appointing an eligible registered elector of the Borough of Gettysburg to hold such office until the first Monday in January after the first municipal election occurring more than sixty (60) days after the vacancy occurs, at which election an eligible person shall be elected to the office for the remainder of the term. No person shall be eligible for appointment to fill the vacancy in elective office of the Borough of Gettysburg unless he or she has resided within the Borough of Gettysburg continuously for at least one (1) year immediately prior to his or her appointment; and

WHEREAS, the Borough Council of the Borough of Gettysburg desires to appoint an eligible, registered elector of the Borough of Gettysburg to fill the vacancy in the office of member at-large of the Borough Council due to the termination of residency from the Borough of Jacob W. Schindel and his resignation from that elective office. The person appointed to fill the aforesaid vacancy shall hold such office from the date of this Resolution, subject to his or her taking the required oath of office and providing the required affidavit relative to his or her eligibility to hold such office, until January 3, 2022, which is the first Monday in January following the November 2021 municipal election. At the November 2021 municipal election, an eligible person shall be elected to the office of the member at-large of the Borough Council for the remainder of the term for which Mr. Schindel was previously elected which will expire on January 2, 2024.

WHEREFORE, BE IT RESOLVED, that the Borough Council of the Borough of Gettysburg, Adams County, Pennsylvania, hereby appoints Nicholas J. Redman


as the member at-large of the Borough Council of the Borough of Gettysburg to fill the vacancy in such elective office as a member of the Borough Council that has occurred by the termination of the residency from the Borough of Gettysburg of Jacob W. Schindel and his resignation from such elective office. The aforesaid registered elector of the Borough of Gettysburg, appointed pursuant to this Resolution, shall hold office until the organization meeting of the Borough Council to be held on January 3, 2022, which is the first Monday in January following the November 2021 municipal election. At the November 2021 municipal election an eligible person shall be elected to the office of member at-large of the Borough Council for the remainder of the term for which Mr. Schindel was previously elected which will expire on January 2, 2024.

This appointment to the office of the member at-large of Borough Council of the Borough of Gettysburg is conditioned upon the receipt by the Borough of Gettysburg of a signed affidavit executed and delivered to the Borough Secretary by the aforesaid appointee stating and affirming under oath that: 1) he or she is a registered elector of the Borough of Gettysburg; 2) that he or she resides within the Borough of Gettysburg; and 3) that he or she has resided in the Borough of Gettysburg continuously for at least one (1) year prior to his or her appointment to the aforesaid office.

This action is taken under and pursuant to the power of a borough council to appoint a registered elector of the borough to fill a vacancy in the elective borough office of a member of borough council as authorized pursuant to the Borough Code at 8 Pa. C.S.A. §901.

THIS RESOLUTION DULY ADOPTED according to law on this 23rd day of August, 2021, at a duly advertised special meeting of the Borough Council of the Borough of Gettysburg, Adams County, Pennsylvania.
