

**RESOLUTION NO. 120919-1**

**A RESOLUTION OF THE BOROUGH COUNCIL OF THE  
BOROUGH OF GETTYSBURG, ADAMS COUNTY,  
PENNSYLVANIA, AUTHORIZING THE SALE OF A 2013 FORD  
POLICE INTERCEPTOR SEDAN TO THE BOROUGH OF  
ABBOTTSTOWN, ADAMS COUNTY, PENNSYLVANIA,  
PURSUANT TO SECTION 1201.2 AND SECTION 1201.3 OF THE  
BOROUGH CODE.**

**WHEREAS**, the Borough of Gettysburg owns a 2013 Ford Police Interceptor sedan with an estimated fair market value of four thousand (\$4,000.00) dollars, as provided to the Borough by its motor vehicle fleet manager, Enterprise Fleet Management; and

**WHEREAS**, consistent with section 1201.2(a) of the Borough Code (8 Pa C.S.A. §1201.2(a)), no borough personal property may be disposed of, by sale or otherwise, except upon approval of borough council by resolution; and

**WHEREAS**, consistent with section 1201.3(a)(1) of the Borough Code (8 Pa C.S.A. §1201.3(a)(1)), the advertisement for bids or sale at public auction shall not be required for the sale of borough personal property to a county, city, borough, town, township, institution district, school district, volunteer fire company, volunteer ambulance service or volunteer rescue squad located within the borough; and

**WHEREAS**, the Borough of Gettysburg desires to sell the 2013 Ford Police Interceptor sedan, for its estimated fair market value, to the Borough of Abbottstown, Adams County, Pennsylvania; and

**WHEREAS**, the Borough of Abbottstown has agreed to purchase the 2013 Ford Police Interceptor sedan for the sum of four thousand dollars (\$4,000.00).


**WHEREFORE, BE IT RESOLVED**, that the Borough Council of the Borough of Gettysburg, Adams County, Pennsylvania, does hereby authorize the sale of the 2013 Ford Police Interceptor sedan (VIN #1FAHP2M84DG101913) to the Borough of Abbottstown, Adams County, Pennsylvania, for its estimated fair market value of four thousand dollars (\$4,000.00).

This action is taken under and pursuant to the power of the Borough of Gettysburg to sell Borough personal property upon approval of the Borough Council by resolution pursuant to section 1201.2(a) of the Borough Code and to sell such personal property to the Borough of Abbottstown without the advertisement for bids or the sale

of such Borough personal property at public auction to the highest bidder, consistent with section 1201.3(a) of the Borough Code.
