Below are some initial areas of focus that will be inspected. Some common missing code requirements are listed below; these elements often lead to failed inspections. Please prepare you rental property prior to your inspection.

- ✓ Fire Extinguisher (see A)
- ✓ Batteries for Smoke Detectors (see B)
- ✓ Carbon Monoxide Detector/s (see C)
- ✓ Light bulbs (see H, I, J, & K)
- ✓ Building Address Displayed (see S)
- ✓ Nuisance Vehicles (see V)
- A. A fire extinguisher per rental unit, visible & accessible in kitchen area. [§ 704.5]
- B. Smoke detectors in bedrooms, common hallway, & one on every floor. [§ 704.2]
- C. A carbon monoxide detector near bedrooms, fuel-burning heaters, and attached garage. [§ 310]
- D. Handrails required on stairs with 4 or more risers; includes interior, exterior, & basements. [§ 307.1]
- E. Guards (rails), that contain gaps no more than four inches, are required on every open portion of a stairway, landing, balcony, porch, deck, ramp, or other walking surface, which is more than 30 inches above the floor or grade below. This includes basement stairways & exterior stairways to second & third floor levels. [§ 307.1]
- F. Two electrical outlets required in habitable rooms except bathrooms, laundry rooms & basements which require one. [§ 605.2]
- G. Bathrooms & kitchens require one openable window or a mechanical vent. [§ 403.5]
- H. Bathrooms, kitchens, laundry, boiler, & furnace rooms are required to have lighting fixtures. [§ 402.3]
- I. Common halls shall be lighted. [§ 402.2]
- J. Every exterior and interior means of egress stairway shall be lighted. [§ 402.3]
- K. Clothes dryer vents need to be vented directly outside. [§ 403.5]
- L. All means of egress doors shall be readily openable from the side from which egress is to be made without the use of a key, special knowledge, or effort; deadbolts are acceptable. [§ 702.3]
- M. Combustible material is to be kept three feet or more from furnaces & gas water heaters. [§ 603.3]
- N. Electrical panel boxes are not to have any openings amongst the breakers or otherwise. [§ 605.1]
- O. Electrical wires are secured to structure, junction boxes must have covers, & splices made in closed junction boxes. [§ 605.2]
- P. Electric covers need to be used & in good repair on all receptacles & switches. [§ 605.2]
- Q. Emergency escape & rescue openings for basement bedrooms. [§ 705.1/702.1]
- R. Sidewalk in good state of repair. [§ 21-201]
- S. Address numbers on door or beside door, & alley. [§ 4-101]
- T. Exterior property to be maintained in clean, safe, & sanitary condition & free of rubbish and/or garbage. [§ 308.1]
- U. Property should be free from excessive weeds or plant growth. [§ 302.4]
- V. No inoperable, unlicensed, vehicles in disrepair shall be kept or stored on property. [§ 302.8]
